RESOLUTION NO. 043 OF 2022

PROCLAMATION DECLARING MAY 31, 2022 AS MENTAL HEALTH AWARENESS DAY IN THE CITY OF NATCHITOCHES

WHEREAS, mental health is essential to everyone’s overall health and well-being; and

WHEREAS, all Americans experience times of difficulty and stress in their lives and one in four of all Americans require treatment at some point for mental health; and

WHEREAS, prevention is an effective way to reduce the burden of mental health conditions; and

WHEREAS, there is a strong body of research that supports specific tools that all Americans can use to better handle challenges, and protect their health and well-being; and

WHEREAS, mental health conditions such as depression, anxiety and schizophrenia are real, common and treatable illnesses and with effective treatment individuals can recover and lead full, productive lives; and

WHEREAS, real recovery from mental illness requires community action, understanding and teamwork and is possible due to improved science, increased community support and reduced stigma and stereotypes, but significant barriers still remain; and

WHEREAS, each business, school, government agency, healthcare provider, organization and citizen share the burden of mental health problems and has a responsibility to promote mental wellness and support prevention efforts.

THEREFORE, I, Mayor Ronnie Williams, Jr., do hereby proclaim May 31, 2022 as **MENTAL HEALTH AWARENESS DAY** in the City of Natchitoches and call upon the citizens, government agencies, public and private institutions, businesses and schools in Natchitoches to recommit our community to increasing awareness and understanding of mental health, the steps our citizens can take to protect their mental health, and the need for appropriate and accessible services for all people with mental health conditions. WHEREAS FURTHER, Section 1310 of Title 39 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 39:1310) requires that when “there has been a change in operations upon which the original adopted budget was developed, the governing authority shall adopt a budget amendment in an open meeting to reflect such change;” and

WHEREAS FURTHER, the Office of the Mayor of the City of Natchitoches is the proper recipient of the ARPA Household Assistance Funding as the instrument of the City most capable of properly distributing it to Impacted Households; and

WHEREAS FURTHER, it is the desire of this Governing Authority to appropriate the ARPA Household Assistance Funding to the Office of the Mayor of the City, to be expended by the Mayor of the City, or the administrative designee of the Mayor (the “**Finance Director**”), pursuant to the guidelines published by the United States Department of the Treasury in its final rule implementing the Coronavirus State Fiscal Recovery Fund and the Coronavirus Local Fiscal Recovery Fund established under the American Rescue Plan Act, effective April 1, 2022 (the “**ARPA Guidelines**”).
