AN ORDINANCE APPROVING THE TERMS AND FORM OF A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE CITY OF NATCHITOCHES AND THE NATCHITOCHES CITY MARSHAL'S OFFICE AUTHORIZING THE MAYOR TO EXECUTE THE COOPERATIVE ENDEAVOR AGREEMENT (CEA) BETWEEN THE CITY OF NATCHITOCHES AND THE NATCHITOCHES CITY MARSHAL'S OFFICE WHICH WILL PROVIDE FOR TERMS

WHEREAS, The Louisiana Constitution of 1974, Article VII, Section 14(C), provides that, "[f]or a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual;" and

WHEREAS FURTHER, the City of Natchitoches (sometimes hereinafter referred to as the "City") is a municipality located in the State of Louisiana, Parish of Natchitoches governed under a Home Rule Charter and a Code of Ordinances adopted by Ordinance No. 5 of 1977; and

WHEREAS FURTHER, the City of Natchitoches is specifically authorized under Section 1.06 of the Charter of the City of Natchitoches to provide for the general welfare, safety, health, peace and good order of the City, and further authorized under Section 1.07 of the Charter of the City of Natchitoches "to enter into joint service agreements or cooperative efforts with other governmental agencies and political subdivisions, whether domiciled in Natchitoches Parish or other parishes, including but not limited to the parish governing body, other parish offices and agencies, the City Marshal's office;" and

WHEREAS FURTHER, the City wishes to enter into a Cooperative Endeavor Agreement and or Joint service agreement (the "Agreement") with the Natchitoches City Marshal (the "City Marshal") for the purposes of facilitating the ticketing of junk vehicles and movable objects; and

WHEREAS FURTHER, the City Council of the City of Natchitoches, acting as the governing authority thereof (the "Governing Authority") has reviewed the Agreement, which is attached hereto as an exhibit; and

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Natchitoches, in due, legal, and regular session convened, that the attached Cooperative Endeavor Agreement/Joint service agreement between the City of Natchitoches and the Natchitoches City Marshal office is approved; and

BE IT FURTHER ORDAINED that Ronnie Williams, Jr., Mayor, be and is hereby authorized to execute, for and on behalf of the City of Natchitoches, a Cooperative Endeavor Agreement/Joint service agreement between the City of Natchitoches and Natchitoches City Marshal, substantially in accordance with the draft thereof attached hereto as Exhibit "A".

BE IT FURTHER ORDAINED that if any provisions or item of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Ordinance which can be given effect without the invalid provisions, items or applications and to this end the provisions of this Ordinance are hereby declared severable.

WHEREAS, The Louisiana Constitution of 1974, Article VII, Section 14(C), provides that, “[f]or a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual;” and

WHEREAS FURTHER, the City of Natchitoches (sometimes hereinafter referred to as the “City”) is a municipality located in the State of Louisiana, Parish of Natchitoches governed under a Home Rule Charter and a Code of Ordinances adopted by Ordinance No. 5 of 1977; and

WHEREAS FURTHER, the City Council of the City of Natchitoches, acting as the governing authority thereof (the “Governing Authority”) has reviewed the Agreement, which is attached hereto as an exhibit; and

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Natchitoches, in due, legal, and regular session convened, that the attached Cooperative Endeavor Agreement between the City of Natchitoches and Natchitoches Parish School Board is approved; and

BE IT FURTHER ORDAINED that Ronnie Williams, Jr., Mayor, be and is hereby authorized to execute, for and on behalf of the City of Natchitoches, a Cooperative Endeavor Agreement between the City of Natchitoches and Natchitoches Parish School Board, substantially in accordance with the draft thereof attached hereto as Exhibit “A”.

AN ORDINANCE TO DESIGNATE FUNDS FROM THE AMERICAN RESCUE PLAN TO REMOVE AND DISPOSE OF CERTAIN MOVABLES IN THE CITY OF NATCHITOCHES THAT ARE A DANGER TO PUBLIC HEALTH AND WELFARE AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, the City of Natchitoches (sometimes hereinafter referred to as the “**City**”) is a Municipality located in the State of Louisiana, Parish of Natchitoches governed under a Home Rule Charter and a Code of Ordinances adopted by Ordinance No. 5 of 1977; and

WHEREAS FURTHER, Section 1310 of Title 39 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 39:1310) requires that when “there has been a change in operations upon which the original adopted budget was developed, the governing authority shall adopt a budget amendment in an open meeting to reflect such change;” and

WHEREAS FURTHER, Section 2.10 of the Charter of the Home Rule Charter of the City, approved by the charter commission of the city on July 7, 1975 and the voters at the election of November 1, 1975, requires that any appropriation of funds by the City be enacted by an ordinance of the City Council of the City, acting as the governing authority thereof (the “**Governing Authority**”); and

WHEREAS FURTHER, the American Rescue Plan Act of 2021, enacted by the 117th Congress of the United States of America (“**ARPA**”), appropriated Fifteen Thousand Dollars (\$15,000.00) to the State of Louisiana, which was then appropriated to the City (the “**ARPA Public Health and Welfare**”) for the purposes of providing assistance with removing inoperable vehicles from the roadway of communities that are a safety concern and removing vehicles because of fear of criminal activity surrounding the abandon vehicles, and

WHEREAS FURTHER, the Office of the Mayor of the City of Natchitoches is the proper recipient of the ARPA Funding as the instrument of the City most capable of properly distributing it to Impacted community; and

WHEREAS FURTHER, it is the desire of this Governing Authority to appropriate the ARPA Funding to the Office of the Mayor of the City, to be expended by the Mayor of the City, or the administrative designee of the Mayor (the “**Finance Director**”), pursuant to the guidelines published by the United States Department of the Treasury in its final rule implementing the Coronavirus State Fiscal Recovery Fund and the Coronavirus Local Fiscal Recovery Fund established under the American Rescue Plan Act, effective April 1, 2022 (the “**ARPA Guidelines**”).

NOW THEREFORE BE IT ORDAINED that the defined terms in the recitals of this ordinance (the “**Ordinance**”) are incorporated herein; and

BE IT FURTHER ORDAINED, by the Natchitoches City Council, in legal and regular session convened, that it hereby appropriates the ARPA Funding to Office of the Mayor of the City, to be expended at the direction of the Mayor or the Finance Director, pursuant to the ARPA Guidelines; and

BE IT FURTHER ORDAINED, that the budget of the City be amended to reflect the receipt of the ARPA Funding and its designation for expenditure by the Mayor or the Finance Director, for the purposes of properly distributing it to Impacted community; and

BE IT FURTHER ORDAINED, that this Ordinance shall become effective immediately upon adoption; and

BE IT FURTHER ORDAINED, that if any provision of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Ordinance which can be given effect without the invalid provisions, items or applications, and to this end the provisions of this Ordinance are hereby declared severable; and

BE IT FURTHER ORDAINED, that all Ordinances or parts thereof in conflict herewith are repealed.

AN ORDINANCE TO DESIGNATE FUNDS FROM THE AMERICAN RESCUE PLAN TO PURCHASE A VEHICLE FOR THE CITY OF NATCHITOCHES TO FURTHER THE PROMOTION OF PUBLIC HEALTH AND WELFARE AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, the City of Natchitoches (sometimes hereinafter referred to as the “**City**”) is a Municipality located in the State of Louisiana, Parish of Natchitoches governed under a Home Rule Charter and a Code of Ordinances adopted by Ordinance No. 5 of 1977; and

WHEREAS FURTHER, Section 1310 of Title 39 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 39:1310) requires that when “there has been a change in operations upon which the original adopted budget was developed, the governing authority shall adopt a budget amendment in an open meeting to reflect such change;” and

WHEREAS FURTHER, Section 2.10 of the Charter of the Home Rule Charter of the City, approved by the charter commission of the city on July 7, 1975 and the voters at the election of November 1, 1975, requires that any appropriation of funds by the City be enacted by an ordinance of the City Council of the City, acting as the governing authority thereof (the “**Governing Authority**”); and

WHEREAS FURTHER, the Office of the Mayor of the City of Natchitoches is the proper recipient of the ARPA Funding as the instrument of the City most capable of managing the Vehicle Purchase; and

WHEREAS FURTHER, it is the desire of this Governing Authority to appropriate the ARPA Funding to the Office of the Mayor of the City, to be expended by the Mayor of the City, or the administrative designee of the Mayor (the “**Finance Director**”), pursuant to the guidelines published by the United States Department of the Treasury in its final rule implementing the Coronavirus State Fiscal Recovery Fund and the Coronavirus Local Fiscal Recovery Fund established under the American Rescue Plan Act, effective April 1, 2022 (the “**ARPA Guidelines**”).

NOW THEREFORE BE IT ORDAINED that the defined terms in the recitals of this ordinance (the “**Ordinance**”) are incorporated herein; and

BE IT FURTHER ORDAINED, by the Natchitoches City Council, in legal and regular session convened, that it hereby appropriates the ARPA Funding to the Office of the Mayor of the City, to be expended at the direction of the Mayor or the Finance Director, pursuant to the ARPA Guidelines; and

BE IT FURTHER ORDAINED, if necessary, that the budget of the City be amended to reflect the receipt of the ARPA Funding and its designation for expenditure by the Mayor or the Finance Director, for the purposes of facilitating the Vehicle Purchase; and

BE IT FURTHER ORDAINED, that this Ordinance shall become effective immediately upon adoption; and

BE IT FURTHER ORDAINED, that if any provision of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Ordinance which can be given effect without the invalid provisions, items or applications, and to this end the provisions of this Ordinance are hereby declared severable; and

BE IT FURTHER ORDAINED, that all Ordinances or parts thereof in conflict herewith are repealed.

WHEREAS, the City of Natchitoches (CITY) awarded the bid to Williams Equipment Services, LLC (CONTRACTOR) on March 28, 2022 by Ordinance No. 014 of 2022 in the amount of **\$1,177,046.23** for FY 2021-22 Phase 1 Street Rehabilitation (Bid No. 0641); and

WHEREAS, on **May 23, 2022**, the City Council approved **Change Order No. 1** in the amount of **\$130,370.29** making the revised contact total **\$1,307,416.52**; and

WHEREAS, on **June 27, 2022**, the City Council approved **Change Order No. 2** in the amount of **\$17,719.73** making the revised contact total **\$1,325,136.25**; and

WHEREAS, on **November 18, 2022** the City Engineer Nick Verret issued **Change Order No. 3**, fully described in Attachment “A”; and

WHEREAS, the contract sum will be increased by this Change Order No. 3 in the amount of **\$99,854.62** and the revised contract total will be **\$1,424,990.87**; and

WHEREAS, the allotted Contract Time will be increase proportionally from Two Hundred Two (202) Calendar Days to Two Hundred Seventeen (217) Calendar Days; and

WHEREAS, the CITY is of the opinion that Change Order No. 3 is in the best interest of the CITY.
